1. Successful Submission of Electronic Clinical Quality Measures

Measure Description:

This measure will track the number of eCQMs that are successfully reported by Persivia to CMS, during the 3 month long submission period.

Justification:

This measure will provide a count of the number of eCQMs that are calculated by Persivia for our reporting clients, and how many of those eCQMs were successfully reported to CMS during the submission period. Persivia reports eCQMs to Quality measurement programs like PCF, MIPS, ACO, etc.

Expected Outcome:

The measure will identify the number of eCQMs calculated versus the number of eCQMs successfully reported to CMS for a given period. This measure will also track the number of QRDA Cat I and III files being exported out of Persivia and the number of QRDA Cat I files being imported into Persivia.

Successful submissions to CMS confirms compliance to the associated certification criteria c(1)-c(3). Similarly, failed submissions would require further investigation into the failures and the percentage of failures. The results from this measure will validate whether Persivia is able to import, calculate, export and report data related to eCQMs.

2. Number of Transition of Care C-CDAs Successfully Sent/Received

Measure Description:

This measure will track the number of transition of care documents sent/received over the course of the calendar year.

Justification:

This measure will track the number of transition of care documents sent and received over a period of time. This in turn is intended to demonstrate the volume of C-CDA transactions coming in and going out of the Persivia platform.

Expected Outcome:

Evidence of a transition of care/referral summary sent and received with all document sections visible to the user in a human readable format.

3. Number of Electronic Health Information Exports

Measure Description:

This measure will provide a count of the number of single patient export files over the course of the calendar year.

Justification:

Exporting patient EHI is necessary to have a comprehensive view of the patient's health information. This measure will provide a count for EHI exported over a period. This measure will also indicate compliance to the HIT requirement to have patient EHI exported in a computable format.



Expected Outcome:

This measure will provide numeric results of successful patient EHI exports over a given period. Successful exports indicate compliance to the ONC criteria. Any observed errors, either by user or by product, will be investigated as observed.

4. Number of Decision Support Interventions

Measure Description:

This measure will provide a count of the number of decision support interventions generated for a user over the course of a calendar year.

5. Access

Measure Description:

This measure will track and provide a list of all non-Persivia applications connecting to the API.

Metric Definition

Number of API requests for a patient ID.Number of API requests for a patient's full data set.

Justification:

This measure will analyze Persivia system logs to track and identify all outside applications that access the API over a given period of time. It will also determine the acceptance and usage of this functionality by end users.

Expected Outcome:

Tracking this measure will provide a count of the different applications accessing the API. This, in turn, determines the real-world interoperability between Persivia and outside applications.

2025 Q1: Initiate client outreach to determine participation in Persivia's Real-World testing effort.

2025 Q2 and Q3: Begin real-world testing with participating clients. Setup scheduled meetings with participants to ensure regular testing and timely completion. Results from testing sessions will be documented in detail, to be used when finalizing the report

2025 Q4: Begin finalizing of the report to be submitted to ONC-ACB. Summarize findings from test exercises in the final report.
